

1. Every visitor has to read our Terms and Conditions and sign the attached form, thereby signifying his agreement to the terms. Visitors under the age of 18 have to have a leagel guardian sign the form.

2. Use of the Adventure Park is dangerous and is always done at your own risk. Forest Adventures is not liable for accidents that occur as a consequence of participants and visitors disregarding our warnings and rules.

3. The Adventure Park can be used by visitors who are at least 1,20 m tall and mentally and physically able to follow our guidlines. Participants under the influence of alcohol, drugs, or medication may not use the Adventure Park. **Children under the age of 12 have to be accompanied by an adult at all times.** Every adult can supervise a maximum of two children (on some tracks up to three children, please ask our staff).

4. Every visitors must participate in our safety training before he can climb. People who fell – during the safety training - that they are not able to complete the course will have their entrace fee refunded. You have to follow the advice of our trainers at all times. In case of violation of our rules, participants can be excluded from further using the Adventure Park. In this case, the entrance fee is non-refundable.

5. When climbing on the obstacle course, you can't wear jewlery; long hair has to be tied into a knot. All items that could pose a danger to the owner or other visitors have to be taken off before using the Adventure Park. This includes purses, rucksacks, cell phones, cameras, etc. Forest Adventures does not assume liability for such items.

## 6. No user may – at any time - be in the obstacle course without having at least one carabiner hooked into the appropriate safety steel wire. The helmet has to be worn at all times while being on the obstacle course or in its proximity.

8. The rented safety gear, consisting of a harness, carabiners und a helmet may not be passed on to other persons. After the obstacle course is completed (three hours after the safety training at the latest) please return the equipment directly. The harness may not be taken off and put on again without having been checked by one of our trainers.

## 9. In the forest – and while wearing our safety gear – smoking is strictly prohibited.

10. Forest Adventures reserves the right to evakuate the obstacle course for safety reasons in case of severe weather conditions (especially storms, hail and thunderstorms). Individual tracks may be closed and operations may be discontinued altogether.

11. Forest Adventures reserves the right to take pictures for commercial purposes. Visitors, who wish not to be on such pictures or movies have to say so during check in. Pictures for commercial uses may only be taken in agreement with Forest Adventures.
